LEAVING A GIFT IN YOUR WILL

How to include Trans Canada Trail in your will

Including a gift in your will is simple. When creating or updating your will, you can take care of your family and include a gift – otherwise known as a bequest – to Trans Canada Trail.

If you already have a will, you can update it by adding a codicil. A codicil is an amending document that changes or deletes an existing provision or adds an entirely new one. Codicils are signed and witnessed in the same way wills are and are kept with the will. If your changes are major, then you should seek professional advice to determine whether you should have a new will drawn up.

What kind of gift can I leave?

Charitable bequests can take many forms and often consist of cash and/or securities. Some of the most common types of bequests, along with sample wording for your will are below:

Residual bequests designate Trans Canada Trail as the beneficiary of part, or all, of your estate – but only after all debts, taxes, administrative expenses and specific bequests have been paid.

A residual bequest is a good choice if you are unsure of the size of your estate.

Sample wording: *“I give to Trans Canada Trail Foundation all (or _____%) of the residue of my estate to be used at the discretion of the organization.”*

Percentage bequests allow you to leave a specific percentage of your estate to be donated to Trans Canada Trail.

Sample wording for a percentage gift in your will: *“I give to Trans Canada Trail Foundation the percentage of (_____)% to be used at the discretion of the organization.”*

Specific bequests designate a specific amount to be donated to Trans Canada Trail.

Sample wording for a specific gift in your will: *“I give to Trans Canada Trail Foundation the sum of \$_____ to be used at the discretion of the organization.”*
